Sub: Constitution of Government Body as per Section 5 of The West Bengal Universities and Colleges (Administration and regulation) Act, 2017.

Madam,

I am directed to refer to The West Bengal Universities and Colleges (Administration and regulation)Act, 2017 (West Bengal Act VII of 2017) and to state that the said Act has already come into force from the 1st April, 2017 vide Notification No. 99-ILC/OM-74L/2017 dtd. 31.03.2017 . With the enforcement of the said Act the Governing Bodies of Govt-aided colleges, whose tenure has expired on or before 1st April, 2017, will now be constituted as per guideline laid down in the Section 5 of the Said Act.

The President shall be a person interested in Education , and shall be nominated by the State Government from amongst the members of the Governing Body or from outside. Provided that the employees or the students of the concerned college shall not be eligible for nomination as President.

Two persons shall be nominated by the State Government and one person shall be nominated by the West Bengal State Council of Higher Education.

The term of the Governing bodies of Govt. aided colleges expiring on and w.e.f. 01-04-2017shall be constituted as per guideline stated above.

All existing members of the Governing Bodies which were constituted immediately preceding the date of coming into effect of this Act shall continue to be the member of such Governing Body until the normal tenure of the Governing Body expires by the efflux of time or unless it is dissolved by the State Government, whichever is earlier.

I am, therefore, further directed to request you to circulate the matter to heads of all Government aided Colleges and all others related to constitution of Governing Body.
