NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

Clause 1

CO-OPERATION

- 1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.
- 1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the second party.

Clause 2

SCOPE OF THE MoU

- 2.1 Both parties believe that close co-operation between the two would be a major benefit to the student community to enhance their skills and knowledge in career in Government sectors.
- 2.2 The First Party will give valuable inputs to the Second Party in teaching/ training methodology so that the students fit into the scenario meaningfully.
- 2.3 The Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in training programs for the First Party. The training and exposure provided to students through this association will build confidence the students prepare for Government competitive exams. The Second Party will provide its Labs/ Workshops/ classroom for the hands-on training of the learners enrolled with the First Party.
- 2.4 The First Party will guide the students of the Second Party about career in government sector.
- 2.5 The Second Party will extend the necessary support to deliver lecturers, infrastructure, introduction support to the students for Competitive Examinations.

Clause 3

VALIDITY

- 3.1 The validity of the agreement will be applicable from the date of agreement till the completion For 2 years.
- 3.2 Both Parties may terminate this MoU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.
