MEMORANDUM OF UNDERSTANDING

This **MEMORADUM OF UNDERSTANDING** is made at Kolkata on the 16th Day of November 2022 between Gokhale Memorial Girls' College (affiliated to the University of Calcutta) with its Principal, Dr. Atashi Karpha office of operation located at 1/1, Harish Mukherjee Road, Kolkata-20 (hereinafter called GMGC) of the one part and Muralidhar Girls' College (affiliated to the University of Calcutta), with its Principal, Dr. Kinjalkini Biswas office located at P-411/14 Gariahat Road, Ballygunge, Kolkata-700029. (here after called MGC) on the other part.

A. WHEREAS

- GMGC expresses its wishes to collaborate with MGC and send to its student to enrol as open cadets in its NCC division.
- MGC expresses its willingness to permit its student 5 in numbers to join as open cadets in vacancies available and provide the institutional training including practical training as per the course curriculum and ensure their appearance for certification examinations as per their eligibility.

This Memorandum of Understanding sets out the terms of understanding between the two institutes in this regard hereto as follows:

1. MGC will offer the following:

- It shall permit the students of GMGC to enrol as open cadets in its NCC division free of cost
- It shall provide the required space for training.
- It shall provide requisite trainers and administrative and manpower support for the security of the students during the period of agreement.
- It shall provide the accessories required during training.
- Students must carry their ID cards and show at the entry gate, failing which they will be denied entry. They must wear and display visibly their MGC ID card inside the GMGC campus.

2. GMGC will comply as follows:

- Students of GMGC shall attend the training classes as per the schedule provided by the MGC and 1 GIRLS' BATTALIAN NCC.
- Students of GMGC shall abide by all the rules and regulations of MGC while attending the training classes in MGC.

C. EXCLUSIVITY

Gokhale Memorial Girls' College will not engage any other institution for training of the NCC for its students during the term of the agreement.

D. TERM AND TERMINATION

1. The agreements shall come into force on their execution and will remain in force until they are succeeded by a definitive agreement. Both the institutions may terminate the agreement by giving six months' prior notice in written terms

to the other side without causing any harm to the students who have not completed the course mentioned.

E. MISCELLANEOUS

- The duration of the contract will be for a period of one year. The renewal for subsequent year will be made after concurrence of both the institutes.
- The Heads of the two Institutions (Principals) shall represent the interests of their respective institutions.
