NOTIFICATION

In exercise of the powers conferred by section 17 read with sections 9 and 16 of the West Bengal Universities and Colleges (Administration and Regulations Act, 2017 (West Ben. Act VII of 2017), the Governor is pleased, hereby, to make the following amendments in the West Bengal Universities and Colleges (Composition, Functions and Procedure for Election of Student's Council) Rules, 2017 (hereafter referred to as the said rules),–

Amendments

In the said rules,-

- (1) In rule 4,
 - (a) After clause (f) insert the following clause:-

"(fa) the Assistant Treasurer- who shall be elected by the class representatives, from amongst them, in the first meeting of the Council; and shall operate the funds of the Students' Council, kept in a Nationalised Bank, jointly with the Treasurer. He/she alone may operate such funds to the limit, where the requirement of tender/ quotation is not mandatory."

(b) to clause (g), add the following proviso:-

"Provided that where the number of students in a class or section or department exceeds by more than forty, the number of class representatives shall be two.";

- (2) in rule 5,-
 - (a) after clause (f), insert the following clause:-

"(fa) the Assistant Treasurer– who shall be elected by the class representatives, from amongst them, in the first meeting of the Council; and shall operate the funds of the Students' Council, kept in a Nationalised Bank, jointly with the Treasurer. He/she alone may operate such funds to the limit, where the requirement of tender/ quotation is not mandatory,"

(b) to clause (g), add the following proviso:-

"Provided that where the number of students in a faculty or department of the University exceeds by more than forty, the number of class representatives shall be two.";

(c) after sub-rule (5) add the following note:-

"Note.— In cases of Universities, where there are more than one General Secretaries elected against each Faculty Council, and such practice is prevailing in such University from time immemorial, the Students' Council of the said University shall be at liberty to continue with such practices, provided the election of officer bearers shall be conducted as per the Rules, 2017."
